KayAnn Varner summarized the plan. Added Ready to Learn Support, operational goals, teachers and staff need a lot of support this year. Need to work with ADE to make sure they are part of the new technology plan. ASD has made changes to their meal plans, facilities and transportation, enhanced cleaning, masks required, no visitors on campus unless necessary, limit use of facilities to others, lot of PD, Class Tag instead of Class Dojo, on-line self-reporting form for staff screening, and temperature checks for students before getting on bus. There is concern about emotional health of students and plan to address these emotional and social needs.

Dr. Dickinson reported ASD has 124 enrolled with potential for 8 more. ASD had drive through registration Thursday and Friday ASD held graduation for 2020 seniors
