Policy Updates for Employee Handbook for ASBVI & ASD

Ms. Young, ADE, stated the legislature's added foster care plan that gives up to 40 hours of leave. The maternity leave has gone up from four weeks of leave to twelve weeks of paid leave. The maternity leave will run in conjunction with Family Medical Leave.

Dr. Atcherson made a motion to approve. Mr. Fagan seconded. Motion Carried.

Discussion Items -

Commissioned School Safety Officer (CSSO)

Mr. Kenreich discussed the importance of safety as both schools are very vulnerable. In 2022, legislatures stated schools need a School Resource Officer (SRO) or CSSO. An SRO is a law enforcement officer, whereas a CSSO is an employee who receives 60-hour training across three phases. Training would be conducted by Bentonville Captain. Mr. Kenreich asked for permission to conduct training in September. The employees trained would include those that are part of the school's Emergency Response Team (ERT). The CSSO Program is coordinated by Ark. State Police (ASP) and handles all the licensing.

Mrs. Pack inquired about cost associated with CSSO Program. Mr. Kenreich stated the cost associated is \$2,200 per person with a minimum of ten attendees per class.

Dr. Cobb and Mr. Caton expressed thoughts on the benefits of the training piece, as well as their concerns regarding liability of armed employees. Mr. Caton recommends that staff and families are polled before a decision is made.

ADE stated that additional training options and legality need to be reviewed and considered.

Mr. Fagan made a motion to table the CSSO Program until more information is received. Dr. Atcherson seconded. Motion Carried.

Mrs. Pack encourages board members to review reports from region 14 regarding the meetings held at ASD and ASBVI, including suggestions for change, and follow-up with school Superintendents.
