Budget and Staffing Information

Secretary Oliva briefly reviewed the 2022-23 school year and the upcoming 2023-24 school year budget. A general rule of thumb is that about 80% of operating funds go towards staffing salaries and other staff expenses each year. The proposed budget for ASBVI is around 80.87% for staff. The budget for ASD is around 85% for staff salaries. These budget charts are aggregated at a high level. Overall dollar allocations at ASBVI, the average expenditures are approximately 7.5 million and ASD is approximately 11.4 million, this breaks down to a little over a hundred-thousand dollars for education per student at each school. The average allocation per student in Arkansas at a non-residential school that excludes specialized services is around twelve thousand per student. Secretary Oliva believes the state makes a great investment in both schools but feels there is room to ask questions. Are funds being allocated to the programs that we want to see the greatest return on investment for our students. Moving forward, Secretary Oliva encourages finding opportunities to be more efficient and prioritize campus projects and safety measures.

Dr. McAllister asked about the discrepancy between the school's allocations. Secretary Oliva and Mrs. Pack stated that is due to the difference in the number of personnel and staff at each school.

Mrs. Pack stated that as a board, there is a big responsibility to ensure the money spent is spent wisely. Mrs. Pack clarified with Secretary Oliva that the board can have a say in how the money is spent. Moving forward, the board and ADE work together to make sure that money is spent wisely.

Secretary Oliva asked that the Board give the Superintendents authority to make decisions, give feedback, and to update the board. Mrs. Pack believes that is the Superintendent's job. The Superintendents alongside their administrative staff to make decisions and advise the board. Board agreed.

ASD Superintendent Search Options

The position announcement submitted has been approved. The position advertisement will be posted once the position is unfrozen. There are several ways to search for a new Superintendent, one being Innivee. Mrs. Pack spoke with Innivee and received their five phase steps. They match candidates both hearing and deaf. The cost of using Innivee is fifty thousand. The second option is with region 14 who has a contract with ADE. A member of region 14 would come to Arkansas and work with the board and

Secretary Oliva informed the board that AR has procurement laws, so state dollars spent over twenty thousand dollars must be competitively bid. This could extend the search process by many months. Board members expressed their concerns and the positive benefits of utilizing their services.

Mr. Fagan made a motion to Invite Region 14 to Arkansas. Dr. McAllister seconded. Motion Carried.

For the Superintendent search a committee must be established of approximately 14 members. A sign-up sheet was previously passed around ASD and several asked to be considered. Mrs. Pack read aloud the names of those signed up. Dr. Atcherson asked about the process going forward for selecting a committee. Mrs. Pack asked that all committee establishment information be directed to ASD Superintendent Assistant. Mrs. Mott asked about the time commitment of the committee. Based on experience, Mrs. Pack stated the committee could meet three to four times.

Dr. Atcherson asked about protecting confidentiality of the candidates. ADE Legal representative stated that the board can go into special session when deliberating the appointment between three candidates. Legal representative stated the committee by itself can meet in a private session, but meeting involving more than two board members must be done in a public forum.
